**TERMS & CONDITION OF AUCTION**

1. The interested person shall have to deposit a bank draft sum of Rs.50000/- on account of earnest money and a copy of CNIC with the undersigned before conducting of auction for participation in the auction proceedings.
2. The highest bidder shall have to deposit 1/4<sup>th</sup> of bid immediately at the fall of hammer and balance amount within 07 days form the receipt of approval.
3. A sum equivalent of 1/4<sup>th</sup> of bid shall be deposited in cash as security for fulfillment of condition of auction which would be released after removal of trees.
4. The successful bidder will have to pay Income Tax as per rules.
5. In case the balance amount of bid is not deposited by the successful bidder within the prescribed period the earnest money already deposited by him will be forfeited and the trees will be put to re-auction.
6. The successful bidder shall remove the trees by digging out their roots from the ground and shall level the land in its original condition at his own expenses to the satisfaction of the undersigned.
7. The successful bidder shall remove / lift the trees within 15 days from the receipt of confirmation regarding approval of his bid.
8. The purchaser shall be responsible for any damage caused by him to Govt / Private property during cutting / lifting of trees.





9. The successful bidder shall abide by any other condition or conditions that may be imposed by the undersigned.
10. In case of any dispute between two or more bidders on any matter the decision of the undersigned shall be final and binding.
11. The undersigned reserve the rights to accept or reject any bid without assigning any reason.
